ABSTRACT

The research method used is a qualitative method with a descriptive approach that uses interviews to describe the data obtained by researchers directly, to obtain a clear and detailed picture of how the use of electronic books (ebooks) by users at the library and archives office of Labuhan Batu district. The data collection techniques used in this study were interviews and observations. Furthermore, the researchers conducted interviews with 5 informants, namely the users at the Library and Archives Service of Labuhan Batu Regency. The results of this study indicate that the use of electronic books (ebooks) by users is that they use electronic books to get references and their information needs such as doing paper assignments given by lecturers. Obstacles experienced by users, especially in unstable networks, lack of collections of books in the e-book, and according to them the obstacles are the lack of experts in the field of e-books so that e-books are not optimal and lack of socialization to users so that some users do not understand in browsing the e-book.

As an information center, the Labuhan Batu district library service is required to be able to provide information services for all levels of society, including members of the public, students, lecturers and others.

Initially, the digital collection was owned by the library and archives service in Labuhan Batu district, when librarians or library employees visited the national library and looked at the ipusnas collection owned by the national library, they thought that if the digital collection was held in the library and archives service in Labuhan Batu district, it would be easier for users. in getting the information they need, as most people in the Labuhan Batu district library service are far from the library and have a long time to come directly to the library, the Labuhan Batu district library and archives service offers and introduces it to the public through the Labuhan Batu district government exhibition In 2018, the Regional Library already has a digital collection called Ipusda Labuhan Batu and it is a faster solution for them to get the information they need.

The digital collections usually provided by the Labuhan Batu district library and archives service are in the form of electronic books or e-books which are

subscribed to by PT. My collection currently has around 700 titles. The Labuhan Batu Regency Library and Archives Service is a public library that has provided an e-book collection for around 4 years. The collection of e-books owned by the Labuhan Batu Regency Library and Archives Service includes various kinds of books, such as: books on religion, economics, law, health, mathematics and science, agriculture, animal husbandry and maritime affairs, children's libraries, engineering and architecture, business, companion education, children with special needs (ABK), vocational training centers (BLK), encyclopedia, management, language and literature, philosophy, forestry, computers, education, psychology, social, general, history, parenting, anti-corruption, high school (SMA), and also novels, as for journals, namely: health and other user needs.

2. RESEARCH METHOD

Obstacles Experienced By Users

Talking about the obstacles experienced by users at the Labuhan Batu district library and archives service, especially in the network section. The network is very necessary in terms of searching for anything, especially electronic books because the network can access information and other needs quickly. it cannot be read, it can only be borrowed and there is a lack of socialization by librarians towards users so that they do not understand how to browse electronic books and there is a lack of experts in the field of electronic books. The availability of books is lacking, they can't read for too long. This is especially experienced by some users who are in certain areas where the internet network is unstable, the availability of book collections and the lack of outreach by librarians to users and experts in the field of electronic books so that some users do not understand how to browse electronic books.

4. CONCLUSION

The conclusions that can be drawn from the results and discussions that have been described in the previous chapters include that the use of electronic books (e-books) by users is that they only use e-books when they are looking for references and needs that they need, such as paper assignment. There are users who rarely use electronic books (e-books) because the collection is not available enough and they choose to come directly to the library. According to them, the printed book collection is more complete than e-books, so they rarely use electronic books and choose to come directly to the library to get what they need. The obstacles experienced by users are problems in the network and also in the e-book collection section which is not large enough and always runs out so that waiting in queues takes a long time, if the book is not connected to the internet the book cannot be read, it can only be borrowed, not downloaded and lack of socialization. librarians towards users so that e-books are less than optimal.
